The invitation letter and the Agenda was drafted by IPOS and sent to UNI that was responsible for sending the invitation to participants and for organization of the event.







Event Implementation

On the beginning of the meeting dr Stanisa Peric, member of the project team at the University of Nis, greeted all attendees and wished successful one-day training. He emphasized importance of the IP management at the HEIs as one of the dimensions carried out in IF4TM project.

In the first part of the training Dragan Vasiljevic (member of IPOS) introduced to the participants the IP rights and distinctive signs like trademarks and industrial design, as well as subject of copyright and soft IP which are very important in the process of innovation development, prototyping and exchange of ideas. After that, Natasa Milovanovic (member of IPOS) held several presentations and covered issues related to the patent protection as the central topic of the training and methodology for searching through patent and design databases. In addition, she demonstrated to the participants how to search some existing patents through the Espacenet software.

Second part of the training started with presentation held by Dragan Vasiljevic, who emphasized the importance of IP management at universities. After that, Natasa Milovanovic presented the available teaching materials which were then distributed to the participants after the end of the training.
